Guaranteed Attendance

A guaranteed number of guest attending is required 5 business days prior to the event, this is the least amount of meals you will be charged for. If the number is not received, the estimated number of guest at the time of booking will be taken as the guaranteed number for billing purposes. Should more people arrive at the function than what you guaranteed, you will be charged for the extra guests.

Prices
